On February 10th we drove the salt-covered old PT to Philly for the AACA annual meeting. The two days of seminars were very worthwhile. In our February meeting in Phelps, this story seemed to prompt a good discussion of various tips and challenges to car restoration. One of my goals in our meetings is to move to more informative and entertaining banter from the back of the room out to our whole group. We have many of our own experts and I know I could learn a lot from all of you.



LIFE'S LITTLE CHANGES HAVE LED ME TO ALTER MY READING HABITS. THOSE NUTRITION LABELS ON THE SIDES OF THE BOXES WILL NEVER BE BEST SELLERS, BUT THEY ARE GETTING MORE ATTENTION NOW

It's actually a good thing because I never realized the full effect of what becomes of what we're putting into our bodies. It makes me wonder why we don't have fluid drain intervals like cars. Imagine how healthy we would be if we could just drain off all of the bad fluid and be invigorated with new. We probably don't read the labels on our automotive products like we should. One of those that could be changing is the one that pertains to the amount of ethanol content in our gasoline. While the matter is likely far from over, it seems the EPA has granted the OK for the ethanol content to be increased from 10 percent we have today to 15 percent. Now, it will take some time to enact this because it also stipulates the fuel for certain model years. What does that mean? Are gas stations going to have additional bays with E15 for those cars who can take it? Who's going to make sure that someone doesn't put the wrong gasoline in their cars? As I said, there's still a lot of work to do.

It has been interesting to follow along the argument pros and cons, and it is certainly something we are going to delve into in the future. We've been through it with the unleaded fuels, then the start of ethanol, so it's nothing new but does bear watching. Knowing what you are putting into your car (reading the labels) is a key to making it last.

For nearly as long as the AACA Library has existed, many people associated with the library have always wanted a bookmobile to help spread the word about library services and the antique automobile hobby in general. We are happy to say that the dream will now become a reality!

Tom Gibson, of <u>Crossroads Restorations</u> in Anderson, SC, is donating his 1955 Chevrolet 3600 Bookmobile to the library! This vehicle brought library materials to residents of Anderson County, South Carolina from 1956 until its retirement in 1991. The book box was made by the Rock Hill Body Company of Rock Hill, SC. RHBC started as the Rock Hill Buggy Company when they began building Model T truck bodies, and also made the Anderson car from 1916-1925.

The library will be taking ownership of the vehicle in early April and with any luck, you will see it at a meet or tour near you in the not-too-distant future! Already volunteers are lining up to help restore and accessorize the bookmobile; it will be a real conversation piece for quite some time.

The library is thankful for Mr. Gibson's generosity and we look forward to bringing the bookmobile back to life doing just what it was

built to do!
